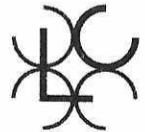

All Skaters must sign in at the check-in table before entering the ice. All benefits of skate school expire on the last day of class; unused guest passes, make-ups, etc.

Terms & Conditions of Enrollment:

- All Applicants must pay tuition in Advance. Parents/Guardians must stay at the rink during minor child's lesson.
- Lessons will be given at the time and place indicated on the application. We reserve the right to change the day and time. Lessons may be postponed if the government mandates closure due to a public emergency.
- In the event students cannot attend a scheduled lesson, a make-up lesson may be taken. There will be no credits or refunds for absences. All make-up lessons must be made by the last day of the term.
- There are no refunds given for students wishing to cancel enrollment. However, credit may be given at the discretion of the Skate School Director. Any requests for credit must be made in writing to the Skate School Director. Student I.D. card is to be turned in with written credit request. Credit will have an expiration of 1 year out from date of credit approval.
- This semester includes: One (1) lesson per week, FREE Admission to all public skating sessions on a space-available basis, and skate rental included only on lesson day. You must show a student I.D. card to receive benefits; must check in with rink staff, show I.D. card, and wear a wristband, to receive free admission to public skate sessions.
- I grant to RMSC the right to photograph my child and use their pictures, silhouette, or other reproductions of my child's physical likeness in connection with advertisements, publications, and/or videotapes. These reproductions may include an exhibition, internet web pages, incorporation into publication, a television broadcast, skating rink advertisement or promotion, the use of videotapes, VHS, DVDs, or any other recording device. And may be used after the last day of class.
- Rink Management Services Corporation manages the ice rink on behalf of the owner. The above-named student and their parents or guardians agree that RMSC and owner are not responsible for loss or damage to any personal property or any injury or illness sustained during the activity or caused by any pre-existing condition.
- I the undersigned parent or legal guardian of the above-named participant hereby authorize the instructors, coaches, or employees of RMSC, to consent to medical, dental, or surgical examination and/or treatment of the above-named participant and, in case of emergency authorize treatment or care at any hospital.
- Customers acknowledge that ice skating is a potentially hazardous activity which can result in injury or other harm. Customer, on behalf of themselves and any minor children, for whom the customer has purchased a contract, hereby releases RMSC and Owner, their owners, agents, and employees from claims of liability, including claims based upon ordinary negligence of RMSC and Owner for damage or injury to the customer and any minor children for whom the customer purchased classes. Thereby accepting the full responsibility for any or all damage or injury of any kind resulting from skating activity. It is expressly understood that this release is not intended to extend to gross negligence or reckless conduct on the part of RMS.
